The Company had on 23 April 2015 obtained a mandate from its shareholders for Carlsberg Brewery Malaysia Berhad Group to enter into recurrent related party transaction with Carlsberg Hong Kong Ltd ("CHKL") and Hanoi Vungtau Beer Joint Stock Co. ("HVTB") respectively, as disclosed in the Circular to Shareholders in relation to the Proposed Renewal of Shareholders' Mandate for Recurrent Related Party Transactions of a Revenue or Trading Nature and Proposed New Shareholders' Mandate for Recurrent Related Party Transactions of a Revenue or Trading Nature dated 23 March 2015. The Board of Directors of the Company wishes to announce that pursuant to Paragraph 10.09(2) of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad, the Company has on 3 February 2016 recorded that the actual contracted transaction value of the recurrent related party transaction of a revenue or trading nature with CHKL and HVTB respectively, has exceeded the estimated value by more than 10% as appended below:
